



## **OCBC CYCLE 2026 – OCBC Cardmembers and OCBC App Promotions**

### **Terms & Conditions for OCBC Cycle 2026 – OCBC Cardmembers and OCBC App Promotions (“Promotions”)**

#### **Eligibility**

1. OCBC credit/debit card members will be entitled to a 10% discount off the prevailing registration fee when they sign up for OCBC Cycle 2026 (the “Event”) with their OCBC cards via the Official Event Website.
2. First 500 participants who register from 6 February 2026 via the Official Event Website using OCBC App (“Participants”) will receive S\$2 in cashback if they register for the applicable categories (“Cashback”). The Cashback will be credited via PayNow to the mobile number provided in the Event’s registration form.

#### **General**

3. The Promotions are only applicable for registration under the following categories:
