



## OCBC Cycle 2026 – Disney-themed Tee Campaign

### Terms & Conditions for OCBC Cycle 2026 – Disney-themed Tee Campaign (“Contest”)

Where you have provided the personal data of other individuals to the Contest Owner, you confirm that you have obtained the consent from such individuals for the collection, use, and disclosure of their personal data to the Contest Owner for the Purposes.
18. These terms and conditions shall be governed by the laws of Singapore and the participants in the Contest irrevocably submit to the exclusive jurisdiction of the courts of Singapore. A person who is not a participant of the Contest by these terms and conditions shall have no right under the Contracts (Rights of Third Parties) Act 2001 to enforce any of these terms and conditions.
